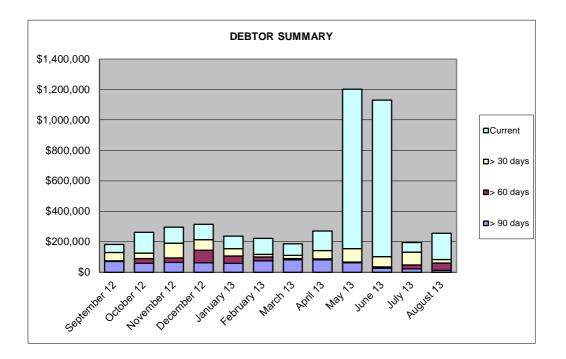

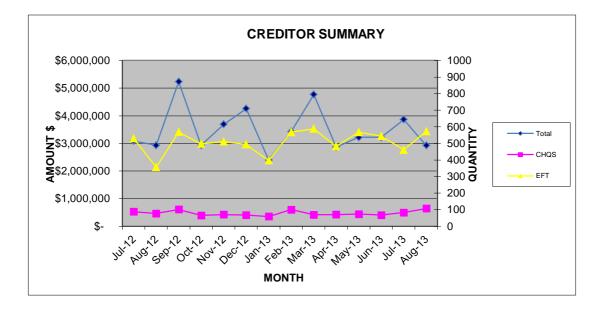

PURPOSE

BACKGROUND

2. Attached is the report detailing rates debtors for the period ended 31 August 2013 (Attachment 1).

4. Debt management is achieved through a range of mechanisms including:

- A two week grace period before missed instalments are declared in default.
- Direct debit, or,
- Other agreed payment options for extenuating circumstances
- 5. Strict protocols are maintained to ensure the Shire is seen to be fair and equitable to all ratepayers.
- 6. Final Notices have been mailed to all ratepayers who have not paid in full, taken up the instalment option or made a direct debit arrangement. Final notices are due for payment on 9 September 2013.
- 7. As noted on (Attachment 1), the Shire has collected \$13,702,888 or 51% of the debt from the date the rates and service charges were raised. As a comparison, last year's collection of rates was not apparent until September due to notices being issued later.

8. No interim rates have been raised since May 2013 these will commence now that the First Instalment date of 12 August 2013 has passed.

DETAILS

Debt Recovery

9. All of the 49 outstanding debts that remain with Dun & Bradstreet have had Judgement entered against them; 42 of these have now substantially paid their rates. Of the remaining, six have gone to the Property Seizure Sale Order (PSSO) stage.

10. The Shire collects its rates debts in accordance with the *Local Government Act* (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.

13. The early raising of rates in July has allowed the Shire's operations to commence without delay and also to earning additional interest income of approximately \$28,000.

PURPOSE

1. To consider supporting one application for funding through the Department of Sport and Recreation's ("DSR") Community Sport and Recreation Facilities Forward Planning Grants Round ("CSRFF").

BACKGROUND

- 2. Through the CSRFF program, the State Government provides financial assistance to community groups and local government authorities to develop basic infrastructure for sport and recreation. The program aims to increase participation in sport and recreation with an emphasis on increasing physical activity through the provision of well-planned facilities.
- 3. The Shire's role in the provision of the funding is to call for applications and assess them in priority order, and rate each application received (Attachment 1).
- 4. The maximum grant approved will be no greater than one third of the total estimated project cost.
- 5. There is no obligation on a local government authority to make any contribution to a project.
- 6. All applications for this Forward Planning Grants round are to be received by the DSR by 30 September 2013 for assessment.
- 7. Successful applicants will be advised in February 2014, with funds to be available in the 2014/2015 financial year.

DETAILS

8. The Shire of Kalamunda has one internal application for the DSR's CSRFF 2013/2014 Forward Planning Grants round.

Kostera Oval Redevelopment

- 9. The Shire of Kalamunda will be submitting an application for the implementation of the Kostera Oval redevelopment project.
- 10. Kostera Oval Reserve is vested with the Shire of Kalamunda. The main sporting oval extends beyond the southern boundary of the reserve by approximately one third onto land controlled by the Department of Education and Training ("DET"). A Licence Agreement exists between the Shire and DET for the Kalamunda Senior High School to use Kostera Oval in return for use of their land.
- 11. In 2007, the Shire engaged McDowell Affleck to investigate the feasibility of expanding the grass playing surface of Kostera Oval Reserve and the development of appropriate infrastructure to complement any proposed oval works.
- 12. In December 2007, Council received the Kostera Oval Feasibility Study and resolved (OCM 132/07):
 - 1. That Council receives the Kostera Oval Reserve Redevelopment Feasibility Study prepared by McDowall Affleck Pty Ltd.
 - 2. That subject to future budget considerations, further investigation be undertaken to complete detailed designs and cost of works for the upgrade of the area adjacent to the War memorial and Agricultural Hall.
- 13. The Shire has received a \$1 million commitment from the State Government towards the implementation of the redevelopment program.
- 14. The aim of the redevelopment will be to increase the amount of available playing field space, upgrade facilities and supporting infrastructure (Attachment 2).
- 15. The redevelopment will occur in two stages. Stage 1 will include the relevelling of the site, new lighting, drainage and cricket nets. Stage 2 will include the development of new clubroom facilities and upgrades to the War Memorial site and parking area at the rear of the Agricultural Hall.

COMMUNITY ENGAGEMENT REQUIREMENTS

- 19. As part of the Kostera Oval Feasibility Study process undertaken in 2007, a significant amount of consultation was undertaken with potential community user groups, Kalamunda Senior High School and the broader community which identified the need to develop the Kostera Oval site.
- 20. The Shire has recently reengaged with the key stakeholders to confirm the proposed redevelopment design. This process was formalised at a Kostera Oval Advisory Committee meeting held on 20 August 2013, whereby the Committee resolved to endorse the draft design.
- 21. Should the CSRFF funding be successful with the DSR, the Shire would continue to keep the stakeholders informed throughout the process.
- 22. The Shire has discussed the proposed project with DSR Staff, who have advised the total amount which the Shire may apply for from the State Government is one third of the total project cost. This portion would include funding of \$1 million commitment already provided and the additional \$810,828 from CSRFF grant funds.

FINANCIAL CONSIDERATION

- 23. Within Council's Ten Year Financial Plan, funding of \$1.5 million per year over the course of four financial years has been included, commencing in 2014/2015.
- 24. A commitment of \$1 million has already been allocated by from the State Government towards the project and will be received by the Shire in 2014/2015.
- 25. The Shire and club representatives have sought assistance from Federal Politicians in an attempt to obtain Federal funding towards the project.
- 26. This upcoming CSRFF Forward Planning Grants round, represents a further opportunity for Council to leverage Shire funds, by increasing the existing external funding commitment to one third of the total project cost.

OFFICER COMMENT

- 32. The DSR requires all applications to be assessed by each local government authority and be provided with a ranking according to the local government's assessment.
- 33. The redevelopment of Kostera Oval has been ranked as the first and only priority, as there is an increasing need for additional public active open space in the Kalamunda area, due to existing open space within the area already being operated at capacity.
- 34. In particular, the Community Facilities Plan identified a short fall in public open space within the Kalamunda area and further supported the outcomes of the Kostera Oval Feasibility Study recommending the development of Kostera Oval to a district level sporting ground.
- 35. Should Kostera Oval not be redeveloped, there are limited opportunities for development of public open space elsewhere.

PURPOSE

1. To seek Council support for the discontinuance of the Kalamunda Community Theatre and Performing Arts Centre Management Committee ("the Committee").

BACKGROUND

- 2. The Kalamunda Senior High School, as a representative of the Minister for Education recently approached the Shire to request a review and renewal of the Agreement relative to the management of the Kalamunda Performing Arts Centre.
- 3. The Kalamunda Performing Arts Centre Agreement ("the Agreement") between the Minister for Education and Shire of Kalamunda was initiated in 1995 and will expire in October 2015.
- 4. The provisions of the Agreement require the Committee to meet at least twice per year.

DETAILS

- 5. As part of the initial review of the Agreement, both parties have agreed the Committee is surplus to needs.
- 6. Historically, the Committee was established to maximise use of the Kalamunda Performing Arts Centre by the school and community given the absence of staff presence, ensuring the interests of both the Shire and Minister for Education were protected.
- 7. The Committee had a role in ensuring the Kalamunda Performing Arts Centre was being utilised and operating effectively.
- 8. The Committee comprises two Councillors, two Minister for Education Representatives and two community representatives.
- 9. Over the past five years, the Kalamunda Performing Arts Centre has evolved from being a "hall for hire" type of facility to a more legitimate Performing Arts Centre with a full time staff presence (Administrator) to arrange shows and address community group booking requests.

10. Community groups and performers utilising the Kalamunda Performing Arts Centre therefore readily have access to the Administrator to meet their requirements and to raise any operational issues.

11. In accordance with the terms of the Management Agreement the Committee was established under the provisions of the *Local Government Act 1995*.

OFFICER COMMENT

- 21. The Kalamunda Senior High School on, behalf of the Minister for Education, has approached the Shire to review and renew the current Agreement removing the Committee requirement which is quite timely, given pending local government elections.
- 22. The management function of the Kalamunda Performing Arts Centre has evolved from a "hall for hire" to having a physical staff presence, providing capacity to coordinate art and cultural activities for the community and enhance customer service for user groups.
- 23. Over the past three years there has been significant improvement in terms of the quality and number of shows; attendance levels; audience appreciation; benefits to the community; and overall financial accountability.
- 24. The Agreement currently states the requirement for both parties to meet on an annual basis which will be maintained within the new agreement.
- 25. The presence of an Administrator at the Kalamunda Performing Arts Centre in contrast to other Shire facility-based Committees suggests maintaining the Committee is surplus to needs.
- 26. Further to this, over the past two years, three of the four scheduled Committee meetings could not take place due to a lack of quorum.
