

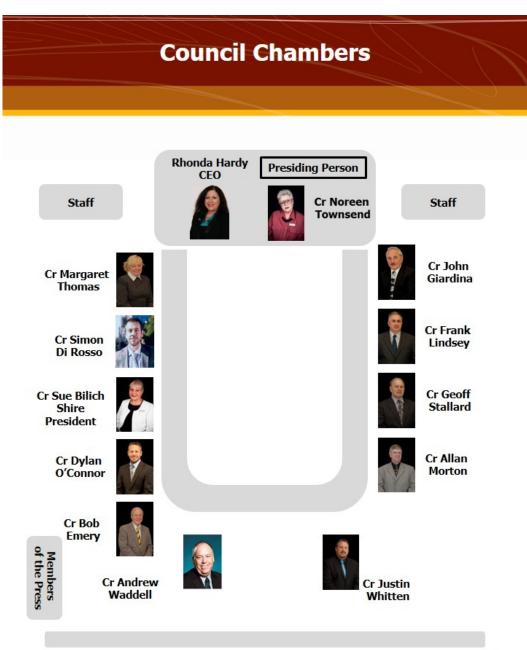

PURPOSE

1. To receive a report on rates debtors for the period ended 30 June 2014. (Attachment 1).

BACKGROUND

2. Rates notices were issued on 8 July 2013 with the final date for payment of rates under a four Instalment Option being 10 February 2014.

The Shire will accept a direct debit payment arrangement to finalise the balance or a special payment arrangement being made in extenuating circumstances. Strict protocols are maintained so the Shire is seen to be fair and equitable to all ratepayers.

- 3. Letter of Demands were sent to 813 ratepayers with outstanding amounts on 12 November 2013. All but 62 have either paid in full or have taken up a direct debit payment arrangement to pay the balance of their rates.
- 4. As noted on (Attachment 1), the Shire has collected \$28,288,536 (including Deferred Balance of \$463,579) or 98.56% of the debt from the date the rates and service charges were raised. As a comparison, last year's collection of rates were lower at 94% mainly due to the delay in issuance of the rates notices.
- 5. Significant progress has been made in raising Interim rates with \$276,070 having been raised to April 2014 so far. Interim rating is now up to date as at 30 April 2014. No further interim rating will be done until after the 2014/2015 Rates have been levied.

DETAILS

Debt Recovery

There are 12 outstanding debts from 2012/13 that remain with Dun &
Bradstreet (D&B) which have had Judgement entered against them. All
have been issued with Property Sales and Seizure Order (PSSO) the next
step is to proceed with Land Warrants for these properties.

- As indicated in point 3 above, there were 62 ratepayers who have not responded to the D&B letters. The Shire has now requested D&B to proceed to Judgement on the 62 properties where no response or payment has been received. Of the 50 properties where Judgement was applied, 25 remain unpaid and a PSSO has been issued.
- Of the outstanding debts that are deemed too small in value (i.e.
 <\$500) to warrant legal action these outstanding rates & charges will now be reflected as arrears on the current rate notice.
- 22 ratepayers have direct debits in place.
- A report will be brought to Council in the new financial year to approve the issuance of a land warrants for those that have proceeded to Judgment and have still not satisfied the claim.

7. The Shire collects its rates debts in accordance with the *Local Government Act (1995) Division 6 – Rates and Service Charges* under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.

PURPOSE

1. To adopt the following amendments to the 2014/15 Budget:-

- a concessional rate of \$0.0018 against the Waste Avoidance and Resources Recovery Levy (WARRL) adopted on the 23 June 2014, part 3 Waste and Rubbish Charges for 2014/15, and,
- Bush Fire Brigade 280612 428 Administration charge for private burns
 10% of total cost, to a maximum of \$50.

BACKGROUND

Waste Avoidance and Resource Recovery Levy

2. As part of the adoption of the 2014/15 Budget at the Ordinary Council Meeting on 23 June 2014 the resolution adopting the WARRL incorrectly included the levy at a figure of \$0.0020 against the Property's GRV valuation as provided by Landgate, instead of the intended figure of \$0.0002.

Bush Fire Brigade Administration Charge – Private Burns

3. The administration charge for private burns included in the Schedule of Fees and Charges for 2014/15 (Attachment 1) was not in accordance with the outcome of discussions with the local Bush Fire Brigades.

DETAILS

Waste Avoidance and Resource Recovery Levy

4. The Department of Environment Regulation is applying stringent control over monitoring and rehabilitation requirements and the Shire has committed to spend an average of \$100,000 a year to deal with the issue of contaminated sites.

In recognition of the impost the State Government introduced a Waste and Resources Recovery Act in 2007 which provided Local Governments the authority to charge a levy to cover among other things, the cost of ongoing monitoring of closed landfill sites.

- 5. To meet the obligation of \$100,000 expenditure in 2014/15, it is proposed to raise a levy against GRV valuations provided by Landgate. A levy of \$0.0002 will achieve this, however the original levy of \$0.0020 adopted by Council would result in an amount of \$1 million being raised.
- 6. Discussions have been held with the Department of Local Government and Communities which advised that the issue can be resolved through the implementation of a concession rate under *S6.47* of the Local Government Act 1995 to neutralise the effect and enable the Shire to raise the intended amount as indicated on the notes forming the budget.
- 7. The rates generation process has ensured that the correct rate of \$0.0002 has been used which will generate approximately \$110,000 to be used for the remediation of contaminated sites.

Bush Fire Brigade Administration Charge - Private Burns

8. The administration charge as adopted, if applied would result in excessive charges being applied to this service and is not what was intended as an outcome of discussions between the Shire and Bush Fire Brigades.

- 10. Section 6.16 (3) of the *Local Government 1995* provides that a Fee or Charge to be imposed by a local government can be amended at any time during a financial year.

PURPOSE

1. To consider approving the request received from the Young Men's Christian Association (YMCA) to enact the three year extension option outlined within the existing Management Agreement for the Kalamunda Waterpark.

BACKGROUND

- 2. The Kalamunda Waterpark is an outdoor aquatic and slide facility owned by the Shire and located on Collins Road in Kalamunda.
- 3. Following a 20 plus year period of external management of the aquatic centre, the Shire was required to expend significant funds between 2008 and 2011 to bring the Centre up to acceptable operational standards suitable for community use.
- 4. Alternative management options were then investigated culminating in the appointment of YMCA in September 2010 to manage the facility.
- 5. In particular, Council resolved the following:

That Council:

- 1. Notes changes to financial projections and a proposed profit sharing arrangement with the prospective management; and
- 2. Approves a three year Management Agreement with YMCA to manage and operate the Kalamunda Waterpark.
- 6. The Management Agreement endorsed by Council included a clause whereby YMCA could seek approval from the Shire to extend the Agreement by a further three years.
- 7. In May 2014, the Shire received a written request from the YMCA to enact the three year extension clause.

8. As such, Council is now requested to consider the request from YMCA to extend the existing Management Agreement for the Kalamunda Waterpark by three years.

DETAILS

- 9. The existing Management Agreement for the Kalamunda Waterpark commenced in 2010 and is based on a profit/loss sharing arrangement. YMCA are provided with an annual Management fee (currently \$53,561), and an overall net operating subsidy, with any profit/loss over and above the agreed net subsidy being shared between the YMCA and the Shire (Attachment 2).
- 10. The Agreement also prescribes a performance guarantee whereby YMCA covers any loss over and above the agreed net subsidy up to half of their management fee.

STATUTORY AND LEGAL CONSIDERATIONS

11. As part of the development of the existing Management Agreement, the tender process was followed in accordance with the *Local Government Act* 1995 Section 3.57, Part 4 *Local Government (Functions and General)* Regulations 1996.

FINANCIAL CONSIDERATIONS

- 14. Over the past three years, the YMCA have required an increase in the operational net subsidy for the management of the Waterpark. This increase in net subsidy has largely been caused by factors that are considered beyond YMCA's control. These being:
 - increased electricity and water expenses
 - increased attractions provided by competitors (i.e. Adventure World, Outback Splash)
 - reduced attractions at the Waterpark
- 15. The following table demonstrates the net subsidy increase over the past three years and the forecast net subsidy for 2014/2015:

2012/13	\$88,845
2013/14	\$134,318 (Forecasted)
2014/15	\$246,109 (Forecasted)

- 16. After an initial burst of interest following the reopening of the facility in late December 2011, overall patronage has declined, in particular the slide attendances. This has been due to a combination of no new attractions being provided as well as increased attractions being provided by competitors such as Outback Splash, The Great Escape and Adventure World.
- 17. The following table demonstrates the attendance variations at Kalamunda Water Park over the past three years:

18. So as to better reflect the value of attractions provided, YMCA have proposed to reduce the slide entry fees for 2014/15 season in an effort to increase the level of community patronage and subsequent secondary spend, i.e. café, pro shop.

OFFICER COMMENT

- Over the past three years, YMCA has overseen the management of the Kalamunda Waterpark in a professional and safe manner and has built up a solid reputation within the community.
- 25. YMCA have developed a significant program of events and new initiatives for the enjoyment of the community and visitors to the Shire of Kalamunda.

 These include but are not limited to; community open days, Australia Day Pool Party, live bands, water polo, birthday parties and school excursions.
- 26. YMCA have implemented an ongoing maintenance programme and their systems for managing reactive maintenance issues has also been effective with minimal days lost due to machinery breakdowns.
- 27. YMCA have also provided effective responses to emergency situations that have arisen, in particular the chlorine gas leak alarm activation in March 2013.
- 28. It is also acknowledged that YMCA have faced significant challenges in terms of maintaining visitations numbers (and corresponding income), given the vastly improved aquatic facilities and amenities being developed and now offered in and around the metropolitan area. For example; Outback Splash, Adventure World.
- 29. As a result, the net subsidy position has increased over this period and without attractions, it is likely to continue and the challenge will be to minimise this increase.

- 30. As part of an overall remedial strategy, YMCA are proposing to further reduce the slides entry fee to increase visitation levels and subsequent secondary spend opportunities (i.e. purchases within café and pro shop).
- 31. Further to this YMCA have implemented a flexible staffing structure that can adjust according to attendance levels without sacrificing safety levels.
- 32. Council may decide to further investigate interest from other leisure facility management companies, however YMCA have developed a strong understanding of the Kalamunda Waterpark and also built a positive relationship with both the Shire and the community.
- 33. In addition, investigating alternative management companies at this stage, would leave limited time for the new provider to prepare for the upcoming season and as such this option is not recommended.
- 34. It is therefore recommended that Council endorses the YMCA's request to enact the three year option extension of the existing Management Agreement for the Kalamunda Waterpark.

Management Fee Model

The Management Fee that YMCA charge the Shire of Kalamunda to operate and manage the Kalamunda Waterpark is currently \$53,561 (adjusted annually by CPI). This Management Fee is expensed in the profit and loss.

In developing the existing agreement, it was considered important that the Shire of Kalamunda's risks are mitigated, as such a profit sharing arrangement was agreed to with YMCA.

The profit sharing arrangement was designed to assist in the ongoing performance guarantee between YMCA and the Shire of Kalamunda:

- In the event of the Centre performing worse than budget (\$246,109), YMCA guarantee to pay the shortfall up to the value of 50% of their management fee.
- In the event that the Centre is performing better than budget (\$246,109) a profit share of 50% of the better than budgeted result would be paid to the Shire of Kalamunda and 50% paid to the YMCA (only after breakeven).
