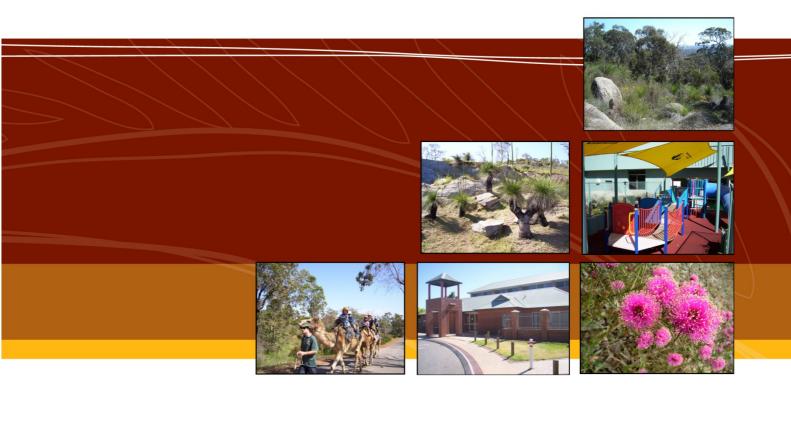

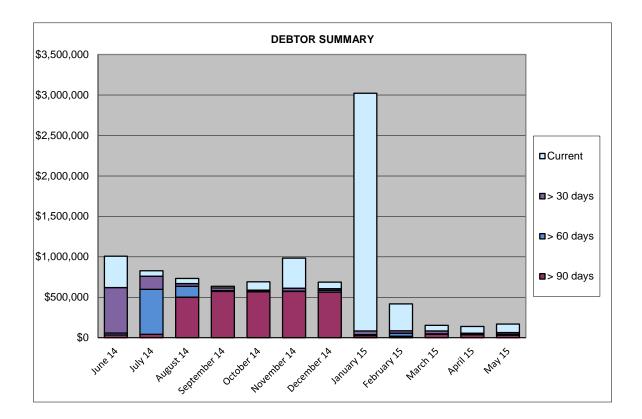

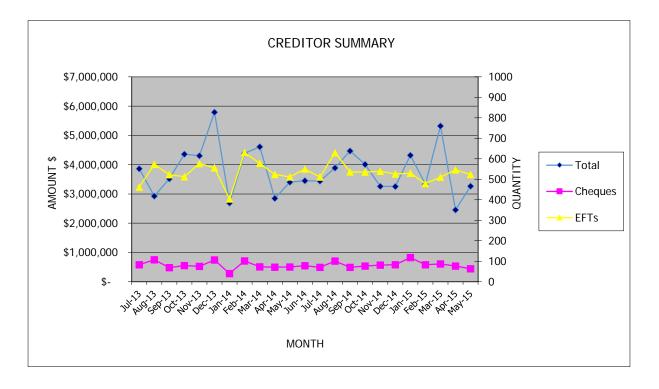

#### PURPOSE

1. To receive the report on rates debtors for the period ended 31 May 2015 (Attachment 1).

#### BACKGROUND

2. Rates notices were issued on 10 July 2014 with the following payment options:-

- 3. A total of 8,858 ratepayers have taken up an instalment option. Of these 1466 have taken up the option to pay by two instalments and 7392 have taken up the option to pay by four instalments. Any amounts outstanding by those ratepayers without an instalment option are regarded as defaulted.
- 4. The Shire can accept a direct debit payment arrangement to finalise the balance or a special payment arrangement is made in extenuating circumstances. Strict protocols are maintained so that the Shire is seen to be fair and equitable to all ratepayers.
- 5. The Shire of Kalamunda now offers direct debit arrangements for instalments, however at this stage there has been little response.
- 6. As noted on (Attachment 1), the Shire has collected \$30,319,189 or 98.08% of the debt from the date the rates and service charges were raised, compared to 97% at the same period last year.
- 7. Interim rates are up to date with \$375,481 raised so far. This is in line with the revised budget projections of \$380,000.

#### DETAILS

# **Debt Recovery**

8.

- There remains 24 Ratepayers from 2013/2014 with outstanding debts. The next step is for the Shire to proceed with Land Warrants.
- The Shire has issued 254 General Procedure Claims through the Courts for the 2014/15 rates and service charges outstanding. Of these 254, the Shire obtained default judgement on 77 properties. A total of 174 of these matters have been closed due to payment being received. There are four matters currently being defended by the ratepayers.
- Of the 77 properties where default judgement has been obtained a total of 60 properties have had a Property Seizure and Sales Order (PSSO) – Goods issued or are awaiting issue through the Courts.
- There are six properties where the rates have been outstanding for three years and over and all legal attempts to collect the rates has been unsuccessful. A briefing session was provided to Council on 25 May 2015. Ward Councillors will be contacting these debtors informing them of the Shire's intention to proceed with a Land Warrant. A separate report to Council will be submitted in the coming months with a recommendation that the land be sold under the provisions of the *Local Government Act* section 6.64.
- Final notices and Letters of Demand have been sent to the remainder of ratepayers who have defaulted on the instalment option, and of the 158 sent 108 have since paid in full. The remaining who have not paid will have their account sent with the 2015/16 rates notice showing the amount outstanding as arrears.

#### PURPOSE

1. For Council to:

- Receive the feedback from the public comment period; and
- Consider approving the request for the Pickering Brook Sports Club (PBSC) to undertake field archery at the PBSC site.

## BACKGROUND

2. In March 2015 (OCM 156/2014), Council was presented with a letter received from the PBSC seeking permission to undertake field archery at the PBSC site, Council subsequently resolved the following:

That Council:

- 1. Writes to Pickering Brook Sports Club to request a copy of a risk management and safety management plan.
- 2. Advertises for a period of 28 days the intent for the Pickering Brook Sports Club to undertake field archery at the Pickering Brook Sports Club site.
- 3. Provides approval to the Pickering Brook Sports Club to undertake Field Archery at the Pickering Brook Sports Club site, subject to the outcome of the public notification period and the provision of a detailed risk and safety management plan.
- 3. The public comment period has now closed, with eight feedback responses received. Council is now presented with the community feedback received, together with the corresponding officer comments (Attachment 1).

# DETAILS

- 4. The PBSC is located on Weston Road, Pickering Brook with the Club recently entering into a lease for the site until 2018.
- 5. The PBSC is the parent club of a number of internal sporting clubs including:
  - Golf
  - Lawn Bowls
  - Football

- Darts
- Cricket
- Pool
- 6. The Shire currently has one Archery club, Kalamunda Governor Stirling Archers (KGSA) which is located at Maida Vale Reserve. KGSA holds memberships for both senior and junior participants across three disciplines, Target Archery, Field Archery and Clout Archery.
- 7. On 5 December 2013, the Shire received a letter from the Department of Parks and Wildlife (DPAW) advising that access to the bushland area at Maida Vale Reserve is no longer permitted due to declared Rare Flora and Fauna having been identified within the site.
- 8. KGSA were recommended to relocate from their existing site at Maida Vale Reserve should they wish to continue their field archery discipline.
- 9. The PBSC have since requested approval to undertake archery activities within their leased premises to accommodate former members of the KGSA. The proposed course is outlined in (Attachment 2).
- 10. Overall the feedback received during the public comment period was supportive of the proposal to undertake field archery at PBSC.

- 13. Staff met onsite with representatives of the PBSC to discuss the proposal and view the proposed layout of the archery course.
- 14. As part of the public comment process, the following initiatives were undertaken:
  - A notification be placed in the local newspapers
  - Multiple signs placed on site
  - A letter drop to nearby residents

#### FINANCIAL CONSIDERATION

15. Given the current level of infrastructure and facilities already being provided at the PBSC site i.e. clubroom, toilets, it is not envisaged that any major upgrades would be required to accommodate the needs of archery, nor has the PBSC requested any additional infrastructure at the site.

- 19. DPAW instructions and advice regarding the strict penalties in place for breaches of the *Environmental Protection Act 1986* including fines of up to \$10,000 which can be enforced for damage per plant, have required both the Shire and KGSA to restrict access to the bushland associated with the Maida Vale site.
- 20. There will be minimal impact on the PBSC site due to the course being planned utilising existing tracks and the area has not been identified to contain any declared rare flora or fauna.

#### OFFICER COMMENT

- 22. The public comment period closed with eight submissions received.
- 23. In assessing the feedback received, all eight of the submissions were supportive of the proposal for field archery to be undertaken at PBSC.
- 24. Of the submissions received, two raised the need to ensure appropriate safety measures were put in place and that the community were informed that the activity would occur.
- 25. As part of the clubs submission, a detailed risk management plan has been provided. The risk management plan is a compilation of best practice examples from other archery clubs and also complies with the standards of both Archery WA and Archery Australia.
- 26. To ensure the community are aware of the activity notification will be provided to the nearby residents via mail drop and signage.
- 27. It is recommended that Council support the request from PBSC to undertake field archery at the site.

   Q. When will the sale of land at 514 Kalamunda Road be settled?
  - A. The sale of land is progressing with negotiations continuing on the vesting of a road reserve. It is expected the property will be sold in the 2015/2016 financial year.

#### 12.1 <u>C&C 23 Draft Monthly Financial Statements to 30 April 2015</u>

- Q. A Councillor noted that at point 7, The comments regarding long service leave and asked if this could be better apportioned in future reports. Director Corporate Services took this question on notice.
- A. It is difficult to apportion the reimbursements for Long Service Leave (LSL) as it would require Human Resources to schedule over 32 staff members who are due the LSL, as to when they are taking their leave and the amount that is being owed by other Councils. The administration effort required would out way the benefits of working this out every month.

In addition, as referred to in point 19, considering a staff cost budgeted at \$22m; the current Enterprise Bargaining Agreement (EBA) in force which allows staff to accumulate up to 8 weeks annual leave, a rough calculation of say 4 weeks outstanding leave would amount to \$1.6 million. The amount accrued which is matched to the payroll system is showing an outstanding of \$1.4 million, in line with management's expectations.

On LSL, the amount reflected is tracking slightly higher than previous year. With the impending merger of Belmont, work priorities resulted in fewer staff taking up LSL in 14/15. Management is reviewing all staff that are due this type of leave and will aggressively pursue this downwards in 15/16.
