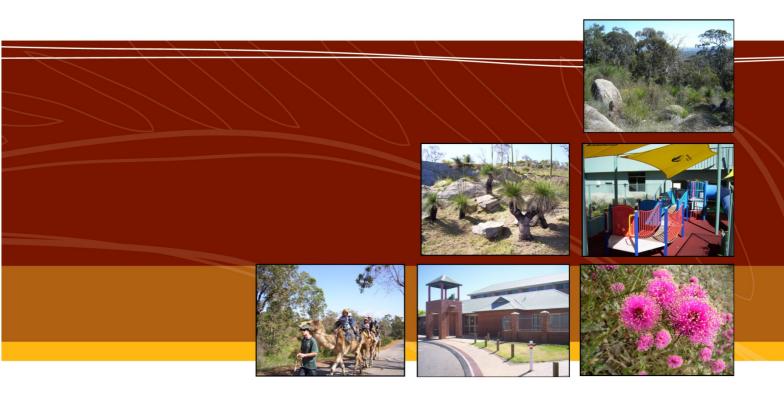

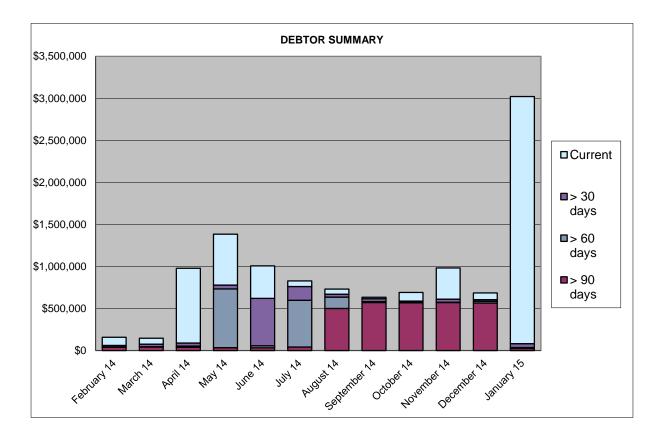

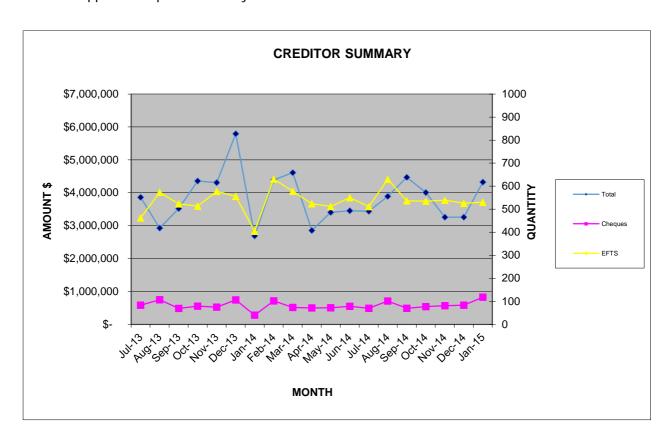

- 3. A total of 8,858 ratepayers have taken up an instalment option. Of these,1466 ratepayers have taken up the option to pay by two instalments and 7392 have taken up the option to pay by four instalments. Any amounts outstanding by those ratepayers without an instalment option are regarded as defaulted.

- 5. The Shire of Kalamunda now offers direct debit arrangements for instalments, however at this stage there has been little response.
- As noted on (Attachment 1), the Shire has collected \$26,421,918 or 86.03% of the debt from the date the rates and service charges were raised, compared to 85% at the same period last year. The rate should normalise by end of February 2015 when the final instalment date is reached.
- 7. Interim rates have commenced and are up to date.

DETAILS

Debt Recovery

- 8. There are now four outstanding debts from 2012/13 that remain with Dun & Bradstreet (D&B) who have had Judgement entered against them. All have been issued with "Property Sales and Seizure Orders", the next step is to proceed with Land Warrants for these properties
 - which will occur in March 2015.
 - There are 24 Ratepayers from 2013/2014, who have received judgement orders; 20 remain unpaid and the Shire has received no response. The Shire will proceed to a Land Warrant now.
 - The Shire have issued 214 General Procedure Claims through the Courts for 2014/2015 and of these 214 we have obtained default judgement on 18 properties and are awaiting confirmation on a further 50 properties. One matter is being defended by the ratepayer and the balance have been either paid in full or are subject to a Direct Debit Arrangement with the majority to be finalised in February 2015.
 - There are six properties where the rates have been outstanding for 3 years and over and all legal attempts to collect the rates has been unsuccessful. A report will be submitted to Council in March 2015 with a recommendation that the land be sold under the provisions of the Local Government Act section 6.64.

9. The Shire collects its rates debts in accordance with the *Local Government Act (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.*

A Councillor asked for more information regarding the recovery process for outstanding debts. The Director Corporate Services noted that a consistent approach is made by the Shire in the recovery of rates debtors. Initially by internal follow-up, if this is unsuccessful they are referred to Dun and Bradstreet who have a range of options available from issuing court judgements to the last stage which is land warrants. He noted that land warrants cannot proceed without coming back to Council and are very rarely used.

The Chief Executive Officer added that generally repossession orders would be lodged, so property inside homes is taken before a land warrant is issued. Generally most stop at this stage.

PURPOSE

1. To receive the Community Care Quarterly Report – December 2014.

BACKGROUND

2. The quarterly report is prepared in accordance with the approved Kalamunda Home and Community Care (KHACC) Business Case (2010 – 2014). The basis of which is:

"That the Home and Community Care Services provided, be within the limits of funding available and reviewed every quarter and reported to Council."

DETAILS

- 3. Referrals for Home and Community Care (HACC) support are received from the Regional Assessment Service. Community Care do not screen for eligibility nor assess potential clients for services and are dependent on these referrals to maintain and increase service levels.
- 4. Inception of the Assessment Framework in 2011 has resulted in increased compliance with eligibility criteria and people receiving services based on assessed need and not just an eligibility status, meaning a person with an ongoing functional disability may be eligible for HACC support but with the provision of the correct assistive equipment may continue to support themselves independently without formalised support.

HACC Service Delivery

- 5. The Volumes Report (Attachment 1) shows how Community Care is performing in relation to its contracted service provision levels for the HACC program for the period of October, November and December 2014.
- 6. The HACC Contract contains service groups that cluster, where appropriate, similar service types together. Service Group 1 includes the following service types: domestic assistance, personal care, social support, respite and other food services.

- 7. Service Group 1 was contracted to provide hours of support against the service types listed in paragraph 6. This allows the service types to be adjusted to meet the needs of eligible clients regardless of the contracted number of hours against each service type.
- 8. Because of this service grouping, a service type such as domestic assistance can achieve higher than 100% of service delivery, providing other service types are not also achieving 100%. The hours are used in a flexible manner to address need.
- 9. During this quarter Community Care was contracted to provide 6285 hours across service group 1 to eligible community members. A total of 4538 hours were provided (72%). This is a 2.5% increase from last quarter.

Domestic Assistance (Service Group 1)

- 10. During this quarter Community Care was contracted to provide 2928 hours to eligible community members. A total of 3359 hours were provided (115%). This is a 5.5% increase from last quarter.
- 11. Impacts on these hours included 743.25 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Domestic Assistance would have achieved 140%, which would have been accommodated by the flexible delivery model assigned to Service Group 1 as detailed in paragraph 7.

In Home Respite (Service Group 1)

- During this quarter Community Care was contracted to provide 450 hours to eligible community members. A total of 104 hours were provided (23%). This is a 2% decrease from last quarter.
- 13. Impacts on these hours included 33.5 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Home Respite would have achieved 30.5%.

Other Food Services (Service Group 1)

- During this quarter Community Care was contracted to provide 96 hours to eligible community members. A total of 21 hours were provided (22%). This is a 3% decrease from last quarter.
- 15. Impacts on these hours included 5.75 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Other Food Services would have achieved 28%.

Social Support (Service Group 1)

- During this quarter Community Care was contracted to provide 1875 hours to eligible community members. A total of 807 hours were provided (43%). This is a 1% increase from last quarter.
- 17. Impacts on these hours included 70.25 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Social Support would have achieved 47%.

Personal Care (Service Group 1)

- 18. During this quarter Community Care was contracted to provide 936 hours to eligible community members. A total of 247 hours were provided (26%). This is stable with last quarter.
- 19. Impacts on these hours included 56.5 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Personal Care would have achieved 32.5%.

Centre Based Day Care (Service Group 4)

- 20. During this quarter Community Care was contracted to provide 9981 hours to eligible community members. A total of 7833 hours were provided (78.5%). This is a 5.5% decrease from last quarter.
- 21. Impacts on these hours included 3684 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Centre Based Day Care would have achieved 115%, this would have been a 28% increase from the last guarter.

Meals on Wheels (Service Group 6)

- During this quarter Community Care was contracted to provide 1500 meals to eligible community members. A total of 1493 meals were provided (99.5%). This is a 14.5% increase from last quarter.
- 23. Impacts included 206 meals that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these meals been provided Meals on Wheels would have achieved 113%.

Transport (Service Group 7)

- During this quarter Community Care was contracted to provide 6816 one way trips to eligible community members. A total of 3858 one way trips were provided (57%). This is a 2% decrease from last quarter.
- 25. Impacts included 1431 one way trips that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness

or being hospitalised. Had these trips been provided Transport would have achieved 77.5%.

Client Support Information and Advocacy (Service Group 9)

26. During this quarter Community Care was contracted to provide 645 hours to eligible community members. A total of 228 hours were provided (35%).

Home maintenance (Service Group 10)

- During this quarter Community Care was contracted to provide 1791 hours to eligible community members. A total of 1613 hours were provided (90%). This is a 6% increase from last quarter.
- 28. In November 2014, the Shire ceased accepting new referrals for Home Maintenance due to a change is staffing arrangements resulting in a risk of not being able to fulfil consumer requests.
- 29. Impacts on these hours included 244 hours that were not provided due to public holidays and clients cancelling services to attend to other commitments, illness or being hospitalised. Had these hours been provided Home Maintenance would have achieved 103%.

COMMUNITY VISITORS SCHEME

- 30. During this quarter Community Care was contracted to provide 270 visits to eligible community members. A total of 251 visits were provided (93%). This is a decrease of 26% since last quarter.
- 31. Impacts include 20 outstanding visit reports from volunteers that were not received in time for this reporting period.

HOME CARE PACKAGES LEVEL 2 (Formally Community Aged Care Packages (CACP))

- During this quarter Community Care was contracted to provide 20 packages to eligible community members. A total of 16 packages were provided (80%). This is a nil variance since last quarter.
- 33. Referrals for packages come from the Aged Care Assessment Team (ACAT). Community Care do not screen for eligibility nor assess potential clients for services and as such, we are dependent on these referrals to maintain and increase service levels.
- 34. Home Care Packages are being transitioned to Consumer Directed Care Packages as of 1 July 2015. Community Care are preparing an implementation plan to drive this program, procedural and cultural change.

FINANCIAL CONSIDERATIONS

- 38. The Community Care Program (HACC), when adjustment is made for grant funding received in advance, has an operating surplus of \$84,773. This reduction in surplus, compared to 13/14, is mainly due to increased payroll expenditure. This increase in expenditure is a result of increased hours worked by direct staff providing in home services and an increase in the number of staff in administration. Payroll expenses are still within budget as of December 2014.
- 39. The Meals on Wheels operating deficit of \$7,234 is understated as two invoices issued by the City of Stirling (our suppliers of meals) had not been received as of December 2014. The estimated operating deficit is \$18,000. While this is \$4000 more than budgeted the receipt of the grant for the final half of the year will see the actuals and the budget more closely aligned.

- During this quarter Community Care had 45 clients exit the HACC program.

- 46. In most services, there are an adequate number of clients to achieve approximately 80% or more volume, however there is always a variance in what is scheduled to be delivered and what is actually delivered.

PURPOSE

1. For Council to receive the feedback from the public comment period and consider adopting the Ray Owen Reserve Master Plan.

BACKGROUND

- 2. In September 2011, Council received the Community Facilities Plan, one of the key issues identified within the Master Plan was the overall lack of Public Open Space (POS) for organised sports.
- 3. The Community Facilities Plan further identified the need to undertake a Master planning process at Ray Owen Reserve in an effort to address the shortfall in POS.
- 4. Since that time, ABV Consultancy in liaison with the Shire, have undertaken a significant amount of research, consultation and planning in the development of the Draft Ray Owen Reserve Master Plan.
- 5. In October 2014 (OCM 156/2014), Council were presented with the Draft Ray Owen Master Plan and resolved the following:

That Council:

- 1. Receives the Draft Ray Owen Master Plan (Attachment 1).
- 2. Advertises the Draft Ray Owen Master Plan for a period of 28 days.
- 3. Notes a community workshop is to be held as part of the advertising process.
- 4. Requests all affected groups and stakeholders be provided with a copy of the Draft Ray Owen Master Plan.
- 6. The workshop with the affected community groups was subsequently held in November, with the key feedback received being to consider providing an

extension to the public comment period and that a further workshop be held with the broader community.

- 7. In November 2014, the Shire President announced in light of the feedback received from the Ray Owen Reserve user groups the public comment period for feedback to be received on the Draft Ray Owen Master Plan be extended until Friday 23 January 2015.
- 8. A workshop was also held with the local community on Wednesday 3 December 2014, with 41 people attending over the course of the session.
- 9. The public comment period has now closed with 16 submissions being received. The community feedback received, together with the corresponding Officer comments appear as an attachment to this report (Attachment 1).
- 10. As such, Council is now presented with the final Ray Owen Reserve Master Plan (Attachment 2) for consideration.

DETAILS

- 11. Ray Owen Reserve, located in Lesmurdie, is Crown Land vested with the Shire for the purposes of recreation. The Reserve is approximately 13.99ha in size and is home to a number of sport and recreation clubs.
- 12. The Ray Owen Reserve Master Plan will aim to provide a clear framework and objectives to assist the Shire in planning, developing, implementing, evaluating and sustaining sport and recreation reserves/facilities at Ray Owen Reserve into the future.
- 13. In particular, the key issues identified within the Master Plan include:
 - Lack of indoor courts
 - Lack of lit outdoor courts
 - Lack of turf space
 - Lack of parking
 - Lack of power and water
 - BMX Club growing rapidly and has outgrown its current club facilities
- One of the key elements of the Draft Master Plan was to consider the current management arrangements of the Ray Owen Sports Centre, to ensure the most appropriate model is in place to drive the facility going forward.
- The Draft Master Plan considers a number of other alternative management options and provides comparisons against the existing arrangements. The Draft Master Plan subsequently recommends the continuation of the existing Licence Arrangement, with a further review to occur in the event that unforeseen circumstances occur which negatively affect the existing model.

STATUTORY AND LEGAL CONSIDERATIONS

16. Local Government Act 1995 Section 3.18 (c) - Effective Management of Local Government Services & Facilities.

POLICY CONSIDERATIONS

17. Nil.

COMMUNITY ENGAGEMENT REQUIREMENTS

- 18. A significant amount of community consultation was undertaken during the development of the Master Plan, including preliminary discussions being held with all clubs based at the Reserve, relevant State Associations, neighbouring local government authorities and local schools.
- 19. The community was then invited to provide feedback on the Draft Master Plan over a 28 day period of public comment in November 2014. This process included direct mail-out to local sporting/recreation clubs, website and copies of the Master Plan located at the Customer Service Centre, Libraries and Recreation Centres. From this, 16 submissions were received during the public comment period.
- 20. A reserve stakeholder workshop was held on Wednesday 12 November 2014 at the Ray Owen Reserve Clubrooms which eight representatives from local clubs and the community attended. ABV Consultancy presented an overview on the development of the Draft Master Plan and invited attendees to ask questions at the conclusion of the session.
- 21. Two of the key points raised at the workshop were to increase the length of the public comment period and to provide an additional workshop to the broader local community. The public comment period was subsequently extended to 84 days between November 2014 and January 2015 and a further workshop provided to the broader community on Wednesday 3 December 2014.
- 22. Six of the 16 submissions received referenced noise issues emanating from the Reserve. One noise complaint was referenced to noise created from the BMX Club PA system and starting gate. Officers have since met with the Club to discuss these issues, with the Club subsequently agreeing to investigate ways in which to reduce the noise created by the starting gate.
- 23. In assessing the layout of the PA system, Officers considered it to be appropriately angled towards the ground and away from the street. The one exception to this was the speaker located on top of the starting gate, which is directed down the side of the track. However, this speaker is only used once per year on the Club's major championship day, to allow spectators who are sitting along the side of the track to hear.

FINANCIAL CONSIDERATION

- The overall cost of implementing the recommendations outlined within the Master Plan is estimated at \$11,833,000 or \$13,391,000 (dependant on which option is taken in terms of the number of additional indoor courts to be built). It should be noted at this stage these are indicative costs, detailed costings will be developed upon implementation of each stage of the Master Plan.
- 25. Within the Draft Master Plan a cost escalation of approximately 4% per year has been applied.
- 26. Within the Long Term Financial Plan, Council has forecast \$5 million across two financial years, 2022/2023 and 2023/2024, to implement the outcomes of the Ray Owen Master Plan. Should Council be supportive of the outcomes of the Master Plan, the timing for the program of works to occur will be considered as part of Council's 10 year Long Term Financial Plan and annual budget deliberation process.
- 27. External funding options have been identified to assist the Shire in the implementation of the Master Plan. Primarily, the Department of Sport and Recreations' Community Sport and Recreation Facilities Fund (CSRFF) is an option where applications for facility developments can attract state government funds to the value of one third of the total project cost.
- A number of the user groups have also indicated to the consultants, they are willing to contribute towards projects either financially or in-kind.

 These opportunities can be further explored as part of the implementation phase of the projects.
- 29. In implementing the outcomes of the Master Plan, it is proposed the following detailed investigations and studies be undertaken as the first priority, with funds to be considered as part of the 2015/16 budget development process for the following projects:
 - Sustainable water supply investigation \$75,000
 - Power supply design and approval process \$50,000
 - Environmental Impact Assessment on the proposed areas for clearing at the site \$20,000
- 30. It is intended the implementation of the schedule of works be staged in a manner that will ensure maximum opportunity for Council to leverage external funding opportunities such as CSRFF.
- 31. As at 1 January 2015 the cash-in-lieu funds totalled \$2.2 million, of which \$294,000 is attributed to Lesmurdie.

STRATEGIC COMMUNITY PLAN

Strategic Planning Alignment

32. Kalamunda Advancing: Strategic Community Plan to 2023

OBJECTIVE 1.9 To provide high quality facilities to meet the needs of our current and our future community.

SUSTAINABILITY

Social Implications

33. The undertaking of a study to provide strategic direction and guidance in the provision of sport and recreation infrastructure at Ray Owen Reserve, will greatly assist in a long term approach in the sustainable provision of sporting facilities within the Region.

Economic Implications

34. Nil.

Environmental Implications

- 35. Whilst Ray Owen Reserve is not a Bush Forever site, careful planning is required in order to ensure the protection of bushland areas.
- 36. The Draft Master Plan has identified the potential to clear an area on the northern side of the Reserve to allow for an increase in the level of parking provision.
- 37. Prior to this clearing occurring, the Master Plan recommends an Environmental Impact Assessment be undertaken to identify if any Declared Rare Flora or Fauna is present.
- 38. One of the key recommendations of the Draft Master Plan is to undertake a detailed investigation into technologies which are most appropriate for Ray Owen Reserve for reducing energy consumption. This will include the potential of installing PV solar panels on the roof of the new indoor courts.

OFFICER COMMENT

- 40. The Draft Ray Owen Master Plan outlines several recommendations in terms of facilities provision, playing field space expansion, future requirements and specific club recommendations.
- 41. The main outcomes for the community will be increased opportunities to participate in physical activities, improved provision of community relevant facilities/services and increased opportunities to be more active.
- 42. In particular, the key recommendations outlined within the Draft Master Plan include:
 - Ray Owen Sports Centre expansion
 - BMX track and facilities upgrade
 - Reserve playing field expansion
 - Additional parking areas
 - Management model for the Ray Owen Sports Centre

Playground

- 43. In receiving the 16 submissions during the public comment period, the major concerns raised on the Draft Master Plan focussed on the following:
 - Provision of only one playground
 - The amount of clearing being undertaken for the new car parking area
 - Hooning
 - Noise issues
- 44. Currently the playground is located in a central location in between the Sports Centre, Football/Cricket Pavilion and the netball courts. This location allows for all users of the reserve to have equal opportunity to access the play space.

- 45. As part of the proposed redevelopment, the extension of the Ray Owen Sports Centre would predicate the need for the existing play space to be relocated. The Draft Master Plan recommended that the play space be relocated to in front of the Sports Centre.
- 46. Of the 16 submissions received, four respondents indicated that this location would not be suitable for all users of the reserve, in particular Football and Cricket Club Users.
- 47. Under the Shire's Facility Development Guidelines, Ray Owen Reserve is considered to be a District Level Open Space, which would include the provision of one play space at the site. However, given the unique layout of the proposed redevelopment and the significant constraints in terms of access to the play space which it will present, it is recommended that an additional play space be included on the Oval side of the Sports Centre.

Parking/Bush clearing

- 48. One of the key developments proposed in the Draft Master Plan is the extension of the car parking area to the north of the Sports Centre. The issue of additional parking being required came through very strongly in all discussions and workshops held with the stakeholders and user groups.
- 49. The additional parking will require an amount of clearing to the bushland area.
- 50. Whilst eight of the feedback submissions received indicated that they were against the proposed clearing, the feedback received was mainly in relation to the clearing of the whole area to the north of the Sports Centre which is not what is recommended. In addition, it should be noted that the rationale for the development of additional parking area has been clearly articulated within the Master Plan and remains valid. The amount of parking space was consistently raised as a major issue throughout the consultation stages in the development of the Master Plan.
- 51. The increased level of amenity and infrastructure being proposed within the Master Plan will only further predicate the need for additional parking space to be provided.
- As part of the detailed design process for the parking areas, it is intended that a number of options will be considered to retain as many of the trees as possible e.g. compacted gravel to create an informal parking area, retaining of trees on median strips and islands etc. This type of approach will ensure that the need to provide additional parking space is balanced with also retaining trees of significance.

Ray Owen Sports Centre Management Agreement

- Draft Master Plan indicates that whilst the existing model is performing well, there is no need for any change to occur and subsequently recommends the Shire enter into a five plus five year licence arrangement with Kalamunda and Districts Netball Association (KDNA) and Kalamunda and Districts Basketball Association (KDBA). As such, it is intended to present a Draft Agreement to Council in March/April to this effect.
- In implementing the outcomes of the Master Plan, it is recommended that the first stage be to undertake further investigations into the availability of water and power together with an environmental assessment of the proposed area to be cleared.
- In summary, it is recommended that Council endorse the Draft Ray Owen Master Plan inclusive of the following amendments:
 - Include provision of a second playground area;
 - Notes that the retention of trees within the proposed new car parking area will be considered as part of the detailed car parking design process.

Marion Rolfe from Gooseberry Hill spoke in favour of the recommendation.

A Councillor asked if the Kalamunda District Basket Ball Association were anxious to have the paperwork finalised for a new licence, Marion Rolfe confirmed that this was the case.

A Councillor asked what the level of player numbers were for the coming year. Marion Rolfe responded that they were almost full, they anticipate being completely full within two weeks. Netball are currently taking registrations and it is unlikely that they will not also be completely full. The two Associations are using more than 95% of their available time and also now hire out to other venues – spending money that could be spent at the Ray Owen Centre.

A Councillor asked, on a weekly basis, how many people would go through the centre each week. Marion Rolfe responded that March to September 11,990 people each week and from September to March 6,500 each week.

A Councillor asked if it was possible to move quickly with the new licence for this facility. The Manager Community Development noted that unless something unforeseen arises, a report will be presented next week.

A Councillor asked if there was any way to bring this project forward, the Chief Executive Officer noted that this would be up to Councillors to decide as they go through the Budget and the Long Term Plan while looking at all the other priorities in front of Council, without impacting on the Shire's sustainability.
