



PURPOSE

1. To receive the report on rates debtors for the period ended 28 February 2015 (Attachment 1).

BACKGROUND

2. Rates notices were issued on 10 July 2014 with the following payment options:-

- 3. A total of 8,858 ratepayers have taken up an instalment option. Of these 1466 have taken up the option to pay by two instalments and 7392 have taken up the option to pay by four instalments. Any amounts outstanding by those ratepayers without an instalment option are regarded as defaulted.
- 4. The Shire can accept a direct debit payment arrangement to finalise the balance or a special payment arrangement is made in extenuating circumstances. Strict protocols are maintained so that the Shire is seen to be fair and equitable to all ratepayers.
- 5. The Shire of Kalamunda now offers direct debit arrangements for instalments, however at this stage there has been little response.
- 6. As noted on (Attachment 1), the Shire has collected \$31,172,975 or 95.44% of the debt from the date the rates and service charges were raised, compared to 93.05% at the same period last year. This collection rate has normalised following the final instalment date being reached.
- 7. Interim rates have commenced and are up to date.

DETAILS

Debt Recovery

- 8.
- There remain 24 ratepayers from 2013/2014 with outstanding debts of these, 20 have had judgement entered against them. The next step is for the Shire to proceed with Land Warrants. A briefing will be provided to Council in April 2015 with respect to the utilisation of Land Warrants.
 - The Shire have issued 214 General Procedure Claims through the Courts for the 2014/15 rates and service charges outstanding. Of these 214, the Shire has obtained default judgement on 18 properties and are awaiting confirmation on a further 50 properties. One matter is being defended by the ratepayer and those who have not paid in full are being organised for further enforcement in early April 2015.
- There are six properties where the rates have been outstanding for three years and over and all legal attempts to collect the rates has been unsuccessful. A report will be submitted to Council in April 2015 with a recommendation that the land be sold under the provisions of the *Local Government Act section 6.64*.

STATUTORY AND LEGAL CONSIDERATIONS

9. The Shire collects its rates debts in accordance with the *Local Government Act (1995) Division 6 – Rates and Service Charges* under the requirements of *subdivision 5 – Recovery of unpaid rates and service charges*.

PURPOSE

1. For Council to consider a request received to undertake Field Archery shooting at Pickering Brook Sports Club (PBSC).

BACKGROUND

- 2. The Shire currently has one Archery Club (Kalamunda Archery Club) which is located at Maida Vale Reserve on Ridge Hill Road.
- 3. Kalamunda Archery Club (KAC) hold memberships with both senior and junior participants across three disciplines, Target Archery, Field Archery and Clout Archery.
- 4. The KAC initially only utilised the Maida Vale site for Target Archery, however, as membership grew and demand increased, the Club expanded to include Field Archery at their location. Field Archery was undertaken in the adjacent bushland area.
- 5. On 5 December 2013, the Shire received a letter from the Department of Parks and Wildlife (DPaW) advising access to the bushland area on the existing Archery Club site is no longer permitted due to declared Rare Flora and Fauna having been identified within the site.
- 6. In October 2014, Council subsequently resolved to provide the KAC with a new 5 + 5 year lease, with amended boundaries to reflect the need to restrict access to the adjacent bushland area.
- 7. Since this time, a request has been received from the PBSC to allow former members of the KAC to undertake archery activities on the PBSC site.
- 8. Council is now presented with the request to undertake Field Archery at the PBSC for consideration (Attachment 1).

DETAILS

- 9. PBSC is located on Weston Road, Pickering Brook with the Club recently entering into a lease for the site until 2018.
- 10. PBSC is the parent club of a number of internal sporting clubs including, Golf, Lawn Bowls, Football, Darts, Cricket and Pool.
- 11. The KAC were recommended to relocate from their existing site at Maida Vale Reserve should they wish to continue their Field Archery discipline.
- 12. Field Archery is set up similar to golf, in that you walk from target to target around a set course. The challenge is shooting uphill and downhill and across slopes, bushland and different light conditions.
- 13. The PBSC have since requested approval to undertake archery activities within their leased premises to accommodate former members of the KAC. The proposed course is outlined within (Attachment 1).

STATUTORY AND LEGAL CONSIDERATIONS

- 16. Staff met onsite with representatives of the PBSC to discuss the proposal and view the proposed layout of the archery course.
- 17. The proposed course will utilise existing tracks within the leased area and the targets are proposed to be located in strategic locations away from any possible pedestrians.
- 18. Should Council be supportive of the proposal to undertake archery at the PBSC, it is proposed that the following initiatives be undertaken to inform the community and seek public comment:
 - A notification be placed in the local newspapers
 - A sign placed on site
 - A letter drop to nearby residents

FINANCIAL CONSIDERATION

- 19. As part of the application received, the PBSC have not requested any additional infrastructure at the site.
- 20. Given the current level of infrastructure and facilities already being provided at the PBSC site i.e. clubroom, toilets, it is not envisaged that any major upgrades would be required to accommodate the needs of archery.

OFFICER COMMENT

- 27. The submission received to undertake Field archery activities at the PBSC, will provide the opportunity for former members of the KAC to continue their chosen discipline in a safe and suitable environment.
- 28. It is envisaged that the proposal will require no up-front capital investment from the Shire due to the already existing level of infrastructure and facilities available at the Pickering Brook Sports Club site.
- 29. In order to ensure the community are aware of the details of where the activity is proposed to occur, it is recommended that a notification of the activity be advertised to the community. In addition, that the PBSC be requested to provide detailed safety and risk management plans.
- 30. It is recommended that Council approves the proposal to undertake Field Archery at the PBSC (as per the site plan attached), subject to the outcome of the public notification period and the provision of a detailed safety and risk management plan.

A Councillor asked if signage to warn the public was to be erected around the perimeter of the proposed area, the Manager Community Development confirmed that this would be the case, and there would also be a notification in the papers and a letter drop to the surrounding area.

A Councillor asked if this activity would be restricted to currently active members, the Manager Community Development indicated that the club was hoping the activity would help the club to grow and encourage new membership.

The Presiding Member noted that the two members of the public gallery had come to listen to this item and asked if they wished to address the meeting. Daniel Trout accepted the offer to speak and informed the Committee he is a long standing member of Kalamunda Archery Club and he hoped to coach members at the Pickering Brook Sports Club. He confirmed signage would be put up when shooting was taking place and removed afterwards.

A Councillor asked if only re-curve bows would be used or if compound bows would also be involved, Daniel Trout responded that there would be lowpondage re-curve; there may be some compounds but these would only be in a certain area. He added that this issue is still being examined but mainly bare bow re-curve with a forty pound max would be used.



- A. Manager Governance and PR will investigate and let the Councillors know details of their operation.

11.3 <u>Cr Frank Lindsey – Waste Services</u>

- Q. Under 12.4 my question regarding waste is recorded incorrectly could the request for changes to *charges* be amend to changes to *tonnages*?
- A. The Chief Executive Officer noted this would be amended.

12.0 QUESTIONS BY MEMBERS OF WHICH DUE NOTICE HAS BEEN GIVEN

12.1 <u>03. Quarterly Report – Community Care December 2014 – Corporate &</u> Community Services Meeting 16 March 2015

- Q1. A Councillor queried why there is a two percent decrease for in-house respite and he recalled this also showed as a decrease in the previous report. He asked for a reason for this downward trend. The Director Corporate Services answers as follows.
- A1.
- In Home Respite has not received a new referral since December 2013
- We currently have 8 active clients in this service type.
- We received irregular referrals (2 in 2012, 6 in 2013) due to the diverse range of support that the Commonwealth National Respite for Carers program offers opposed to HACC Respite.
- Our service delivery exists by maintaining the current levels for our existing 8 clients, therefore if they (or their carer) cancel a service or have their service fall on a public holiday and opt not to reschedule we have a reduction in hours for the reporting period. Furthermore these clients may have episodes in hospital or residential respite, where a need is not required to reschedule as the carer is getting respite via another avenue.

- There has been talk, but unconfirmed, that when WA HACC transition to the Commonwealth Home Care Program that HACC funded respite will either no longer exist, or will present in a similar format to the National Respite for Carers program (NRCP)
- With growth funding released annually under the Living Longer, Living Better policy and aged care reform, we can consider applying to be a provider of NRCP in the future and provide a better scope of respite options to carers living within the Shire (who can have higher carer needs that a HACC service would provide)
- Q2. A Councillor requested further information regarding paragraph 14 of this report (Other Food Services Service Group 1). The Director Corporate Services answers as follows.
- A2.
 - Other food services is a support type that was meant to support eligible consumers who didn't need a meal provided (e.g. Meals on Wheels) as they had capacity to shop, menu plan, and do some food preparation but may find the idea of cooking a meal challenging.
 - Unfortunately, we have not seen many referrals come through for OFS, and have periodic increases in MOW referrals what is not clear is whether that is fully based on consumer need, or the inexperience of the assessor.
 - Our service delivery exists by maintaining the current levels for our existing clients, therefore if they cancel a service or have their service fall on a public holiday and opt not to reschedule we have a reduction in hours for the reporting period.

12.2 <u>Cr Sue Bilich – Degraded state of Heritage Railway Track</u>

- Q. I have received a letter from the Friends of the Railway Reserve regarding the degraded state of the track through the reserve. Could this please be looked into and actioned as soon as possible?
- A. The Director of Infrastructure responded; the Shire has a budget for 14/15 for maintenance of unsealed tracks which will be expended when quotes are received. This will be spent in this site as a first priority and then other areas as funds permit. Similar works were budgeted and spent in 2011/12 and 2012/13.

12.3 <u>Cr Dylan O'Connor – Ponds at Jacaranda Springs</u>

- Q. What is the maintenance schedule for the ponds at Jacaranda Springs and when is it due for a significant tidy-up?
- A. The Parks Crews undertake the following routine maintenance tasks at Jacaranda Springs:
 - Mowing, brush cutting, spraying and litter removal on a fortnightly basis
 - Garden beds are progressively being mulched

A site inspection revealed that a number of the lakes have Typha infestation. This plant spreads via rhizomes and disperses seed (via wind

and fauna) and is often among the first wetland plant to colonise which makes the plant very difficult to control or keep out of wetlands, lakes and dams. It is also very costly to remove once established.

The Shire has identified the need to control Typha within wetlands across the Shire although this needs to be undertaken strategically, moving from the highest level of the catchment to the lower levels of the catchment due to the method of its spread. Typha also plays a very important role in providing habitat for bird life and other aquatic animals and invertebrates. It is important that planting forms part of the project so habitat is not lost throughout the process.

Last financial year one of the lakes at Jacaranda Springs had Typha removal undertaken by mechanical methods and this year staff have been removing dead and loose vegetation from the lake via hand methods, which is very time consuming.

The budget for 15/16 is the time for Council to consider mechanical methods to reshape and deepen the lakes at Juniper Way Reserve and Jacaranda Springs which currently have issues with increased temperatures and dissolved oxygen. Once this project is complete, the plan is to mechanically remove Typha and follow up with planting, which will be undertaken one lake per year.

12.4 Cr Frank Lindsey – Waste Services

Q. Could some figures on waste be prepared, comparing the tonnes and the cost of the green bins versus the street pickups, similarly for the general wast versus the street pickups.

A follow-up question at the Ordinary Council Meeting on 23 February 2015 requested figures regarding changes to tonnages going through the Transfer Station be added to this question.

A. A detailed email comparing the figures has been sent to all Councillors by the Director Infrastructure Services.
