





#### **PURPOSE**

1. To receive the report on rates debtors for the period ended 31 March 2015 (Attachment 1).

#### **BACKGROUND**

2. Rates notices were issued on 10 July 2014 with the following payment options:-

- 3. A total of 8,858 ratepayers have taken up an instalment option. Of these 1466 have taken up the option to pay by two instalments and 7392 have taken up the option to pay by four instalments. Any amounts outstanding by those ratepayers without an instalment option are regarded as defaulted.
- 4. The Shire can accept a direct debit payment arrangement to finalise the balance or a special payment arrangement is made in extenuating circumstances. Strict protocols are maintained so that the Shire is seen to be fair and equitable to all ratepayers.
- 5. The Shire of Kalamunda now offers direct debit arrangements for instalments, however at this stage there has been little response.
- 6. As noted on (Attachment 1), the Shire has collected \$29,807,958 or 96.64% of the debt from the date the rates and service charges were raised, compared to 95.94% at the same period last year. This collection rate has normalised following the final instalment date being reached.
- 7. Interim rates are up to date with \$360,350 raised so far. This is in line with the revised budget projections of \$380,000.

#### **DETAILS**

## **Debt Recovery**

- 8. There remains 24 Ratepayers from 2013/2014 with outstanding debts.

  Of the 20 ratepayers who received judgement, the debts remain unpaid and the Shire has received no response from them. The Shire is proceeding towards a Land Warrant under S6.56 of the *Local Government Act 1995*.
  - The Shire have issued 242 General Procedure Claims through the Courts for the 2014/15 rates and service charges due. Of these 242, we have obtained default judgement on 71 and 125 of these matters have been closed due to payment being received. There are two matters that are being defended by the ratepayers.
  - Of the 71 properties where the Shire have obtained default judgement;
     60 properties have had a Property Seizure and Sales Order (PSSO) –
     Goods issued or are awaiting issue through the Courts.
  - Six properties where the rates have been outstanding for three years and over and all legal attempts to collect the rates has been unsuccessful and therefore a separate report will be presented to Council with a recommendation that the land be sold under the provisions of the *Local Government Act 1995 Section 6.64*.

9. The Shire collects its rates debts in accordance with the *Local Government Act (1995) Division 6 – Rates and Service Charges under the requirements of subdivision 5 – Recovery of unpaid rates and service charges.*

 For Council to support the change in the valuation methodology from Unimproved Valuation (UV) to Gross Rental Value (GRV) for a portion of following lots being operated as commercial portion of the following properties:

- a) Lot 51 Carmel Road Carmel Fairbrossen State Winery and Restaurant
- b) Lot 3 Merrivale Road Pickering Brook Core Cider House

#### **BACKGROUND**

2. An application to the Minister for Local Government requires the support of Council prior to the Minister making a determination.

Section 6.28 of the Local Government Act 1995, provides:

- (1) The Minister is to
  - (a) determine the method of valuation of land to be used by a local government as the basis for a rate; and
  - (b) publish a notice of the determination in the Government Gazette.
- (2) In determining the method of valuation of land to be used by a local government the Minister is to have regard to the general principle that the basis for a rate on any land is to be
  - (a) where the land is used predominantly for rural purposes, the unimproved value of the land; and
  - (b) where the land is used predominantly for non-rural purposes, the gross rental value of the land.
- (3) The unimproved value or gross rental value, as the case requires, of rateable land in the district of a local government is to be recorded in the rate record of that local government.

#### **DETAILS**

3. Lot 51 Carmel Road Carmel – Fairbrossen State Winery and Restaurant

The whole of the land situated at lot 51 Carmel Road Carmel is currently rated as Unimproved (UV) General, however a portion of that property is

being operated as the Fairbrossen Restaurant and Tasting and is classed as a licenced restaurant and offers an A la carte menu. The business also offers the restaurant and surrounding area for weddings and functions. The café has been in operation since 2008. Therefore the land use can no longer be classed as predominantly Rural. It will be necessary to seek a split valuation for the Gross Rental Value for the Restaurant and associated buildings that make up the 'commercial business' section of the property.

The residence and vineyard component remain as unimproved value (UV) and rated as UV General.

## 4. Lot 3 Merrivale Road Pickering Brook – Core Cider House

The whole of the land situated at Lot 3 Merrivale Road Pickering Brook is also currently rated as Unimproved (UV) General, however a portion of that property is being operated as the Core Cider House and is classed as a licenced restaurant. The business also offers the restaurant and surrounding area for weddings and functions. Therefore the land use can no longer be classed as predominantly Rural. It will be necessary to seek a split valuation for the Gross Rental Value for the Restaurant and associated buildings that make up the 'commercial business' section of the property.

With the remaining land currently used as an orchard and residence remain as unimproved value (UV) and rated as UV General.

5. Letters were sent on 26 March 2015 to both property owners advising of the Shire's intention to change the rating methodology.

1. To consider a request from Pickering Brook Heritage Group (the Group) for a subsidy of 75% of occupancy costs being for Volunteer and Public Liability Insurance

#### **BACKGROUND**

- 2. At the Ordinary Council Meeting on 25 February 2013 Council adopted Lease Policy LEA1 Community Groups' Lease Council Policy
- 3. The associated procedure noted that the Shire may from time to time consider it warranted to subsidise an association in regards to Building Occupancy costs.

#### **DETAILS**

the council may, with the approval of the Electoral Commissioner, allow the vacancy to remain unfilled and, in that case, the term of the member who held the office is to be regarded in section 4.6 as ending on the day on which it would have ended if the vacancy had not occurred.

- 4. The vacancy in the office of councillor occurred pursuant to section 2.32 (a) of the Act, if the member dies.
- 5. In accordance with Item 4 of the Table to section 2.28 (2) of the Act, the term of office would have expired on the ordinary election day in 2015.
- 6. The Electoral Commissioner has approved the vacancy remaining unfilled until the ordinary election day in October 2015 (Attachment 1).
