# Disability and Carers Advisory Committee Monday 9 May 2022 Function Room, Administration Building

#### 1.0 Official Opening:

#### 2.0 Presentation by Terese Sheahan, Relationships Australia.

Terese provided a brief overview on the Disability Royal Commission. In April 2019, the Australian Government established the Royal Commission into violence, abuse, neglect, and exploitation of people with disability. The Royal Commission is listening to the personal experiences and stories of members of the community. These stories will help the Royal Commission understand the issues impacting people with disability in Australia. The Royal Commission will then make recommendations to the government about what should change.

Key dates for committee to note:

30 June 2022 – last date for people to register their submission. A submission is for people to share their story or experience. There are advocacy organisations that can help people write their submission free of charge.

31 December 2022 – all submissions must be lodged.

Relationships Australia WA offers free counselling and support for anyone affected by the Disability Royal Commission. They can provide counselling in person, online or by phone.

Relationships Australia WA is launching a social media campaign. Terese to share the Facebook post with CDO-IC so this can then be shared on the City's Facebook page.

- 8.2 Stirk Park Playground Upgrade Council endorsed the design for Stirk Park Playground and Skate Park Project for purposes of finalising tender documents at the April 2022 Ordinary Council Meeting and agreed to proceed to final design and call construction tenders for the Project. The proposed improvements at Stirk Park will cater for persons of all age ranges and abilities, which will provide a more inclusive environment at Stirk Park.

- 9.0 Business Unit Update: Provide Committee members with update on business unit.
- 9.1 Kalamunda Compassionate Communities; The City, supported by Kalamunda Palliative Care Unit and Darling Range Hub was successful in obtaining \$20,000 from the Department of Health to establish a Kalamunda Compassionate Communities.

A Compassionate Community is a community that cares for and supports one another, particularly individuals at end of life and their families and carers. This approach relies on strong partnerships between the dying person, their families and carers, friends, local community, service providers, volunteers, community organisations and government and non-government agencies.

- 9.2 My Future Care Introduction to Advance Care Planning Workshop, 30 May 2022, 10am to 12noon at the Kalamunda Agricultural Hall. We all want to have a say in what happens in the last part of our lives. This free workshop delivered by Palliative Care WA will help participants plan ahead and let their families and health care providers know what they want.
- 9.3 Remove Hazards Safe-Tea Event in partnership with Injury Matters and Shire of Mundaring, 14 June 2022, 12pm to 2.30pm at the Boya Community Centre. The event will focus on foot and eye health, preventing falls and home safety. A bus will be provided for City residents if there is a need, which is funded by Injury Matters.
- 9.4 Social Inclusion Forum. The City in partnership with Inclusion Solutions will host a Social Inclusion Forum to promote the development of inclusive communities. The forum will focus on disability, leading into International Day of People with Disability. The proposed date is 1 December 2022. Hosting a Social Inclusion Forum will strengthen the City's Social Inclusion Plan. Guest speakers from the community

will be sourced to present at the forum to speak around the theme of disability. Potential guest speakers to be sourced from local sporting clubs, community organisations and individuals who either live with a disability or provide a service.

The City uses this scoring system to assist with prioritising the individual projects within its budget constraints. Alpine Road has scored within the Low Priority range.</li> </ul>
