8 AGENCY UPDATE

8.1 RED CROSS AM

8.1.1 Red Cross is running Psychological First Aid Training. There was a session held yesterday which 15 people attended and positive feedback was received. We are running a second session on 16th June and will forward an event brite link with further information to LEMC Members who are welcome to attend. The training goes over tools and helps assist front line workers respond in emergencies and at evacuation centres dealing with people in distress. It helps workers to provide support in a psychological perspective. We are open to sessions of up to 20 people but would also add extra dates if we receive enough interest.

8.3 CITY OF KALAMUNDA – FIRE AND EMERGENCY MANAGEMENT

- 8.3.1 Fire Hazard Assessments there were 3500 properties assessed during the season and 75% were compliant with 81 infringements issued.
- 8.3.2 We had the hottest summer on record with 13 days over 40 degrees 5th February we hit 43 degrees.
- 8.3.3 Currently working through the Annual Preparedness Capability Survey.

8.4 KALAMUNDA SENIOR HIGH SCHOOL

- 8.4.1 Helen has an emergency as the building programme is being conducted and they have hit water.
- 8.4.2 Speaking for Kerry as well (Lesmurdie Senior High School) Covid has been our biggest rolling issues. Approximately 60% of students have now had Covid and around 40 to 50% of Staff. This week hit a lot and we are at crisis level. Helen is taking classes and we have had to deploy non-teachers into classes and are tapping into the central pool. Hopefully we are at the peak of the wave and things will start to improve.
- 8.4.3 Mayor Margaret Thomas asked how many students at a guess have been vaccinated?
- 8.4.4 This information hasn't been collected by the school but it is probably similar number to what has been reported in the community.

- 8.6.2 Spoke about a friend who assisted with the Queensland floods, a Salvation Army Volunteer who was handing out money to victims of flooding. The Volunteer noticed that one town was home to a lot of Somalian refugees and that they seemed to handle the problems far better which may be due to their backgrounds dealing with far worse situations. Psychologically there is a difference to how people deal with hardships based on past experiences also.
