

# Terms & Conditions

I understand that this Vehicle Permit is only valid for myself to dispose of my residential waste and I understand that the vehicle permit is not valid for anybody else's waste or any type of commercial / trade waste.

The City of Kalamunda monitors site usage and reserves the right to make further enquiries of the owner of the vehicle and at the premises from which the waste originated.

Waste needs to be carried safely and vehicles bringing waste to the site should at all times comply with the *Road Traffic Act (1974)*.

Residents using a permit are required to also bring their Resident Entry Pass and show their valid Driver's Licence with photo.

## Declaration

I understand that the City of Kalamunda can revoke this Vehicle Permit at any time.

I confirm that the waste I wish to dispose is residential waste originating from my own home and for which I have not received payment. I understand if it is commercial waste it will incur a fee and this is at the determination of Transfer Station staff.

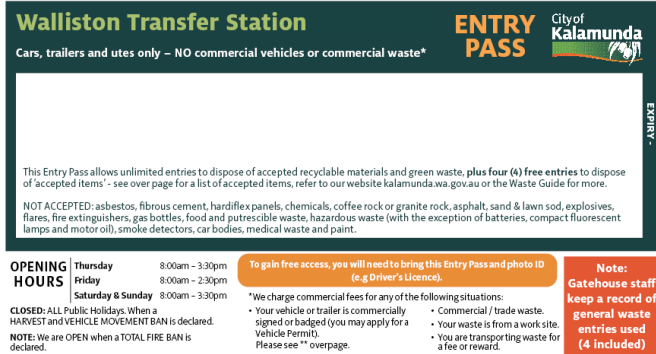

# Residents

City of Kalamunda Residents do not pay fees for non-commercial use of the Walliston Transfer Station. To gain free access, you will need to bring your Resident Entry Pass (example below) along with Proof of Residency (i.e. Driver's Licence).



The Walliston Transfer Station is for residential waste only. We charge commercial fees for any of the following situations:

- » Commercial/trade waste
- » Your vehicle or trailer is commercially signed or badged (unless you have a valid Vehicle Permit)
- » Your waste is from a worksite
- » You are transporting waste for a fee or reward

If you have obtained a Vehicle Permit for a commercially signed or badged vehicle, the City of Kalamunda reserves the right to charge a commercial fee if it is deemed that the waste brought to the site is of a commercial and not a household nature.



# Vehicle Permit Application Form

## For City of Kalamunda Residents

For the disposal of general waste, green waste and recyclable materials at the Walliston Transfer Station.

- » Branded/commercial vehicles and/or trailers
- » Oversized trailers for green waste only
- » Vans up to a maximum of 3.5T GVM
- » Trucks up to a maximum of 3.5T GVM

## Vehicle Permit Information

**The Walliston Transfer Station is for residential waste only. The disposal of commercial waste incurs a waste disposal charge.**

The Vehicle Permit scheme applies to City of Kalamunda residents who use:

- Branded / commercial vehicles and / or trailers
- Oversized trailers for green waste only up to a maximum length of 12ft x 6ft (excluding car towing trailers and horse floats which are not eligible)
- Vans up to a maximum of 3.5 tonne GVM
- Trucks up to a maximum of 3.5 tonne GVM

Vehicle Permits are not available for those living outside of the City of Kalamunda.

The Vehicle Permit system addresses a range of issues, including the disposal of commercial waste and improved health and safety.

To apply for a Vehicle Permit you may either complete the application form online, post one in or drop off a hard copy to the City office at 2 Railway Road, Kalamunda.

### Please note:









- » Vehicle Permits do not have an expiry date. You can continue to use them provided all information on the Vehicle Permit is correct.
- » If you have changed your vehicle or address, please complete a new application form and an updated Vehicle Permit will be posted out to you.

Simply complete, sign and return the application form.

### Recyclables & Green Waste

You are still required to present your Vehicle Permit and your Entry Pass if you are bringing green waste and/or certain recyclables to the Waste Transfer Station. Please refer to your resident entry pass for a list of accepted recyclables.

## Who Requires a Vehicle Permit?

<b>Vehicles and/or trailers</b> with commercial signage (all types and sizes up to 3.5T GVM)		<b>PERMIT REQUIRED</b>
<b>Trucks</b> (up to 3.5T GVM) Must attach proof of the vehicle's GVM (or AGG)		<b>PERMIT REQUIRED</b>
<b>Vans</b> (all types and sizes up to 3.5T GVM) Must attach proof of the vehicle's GVM (or AGG)		<b>PERMIT REQUIRED</b>
<b>Oversize Trailers</b> for green waste only (maximum 12ft x 6ft)		<b>PERMIT REQUIRED</b>
<b>Vehicles with gross weight over 3.5T GVM</b>		<b>NO PERMIT GRANTED</b>
